**Intersection Signing**

To guide you as the operator of an ATV within Clark County's trail system, intersection signs have been installed. The 9" x 9" white legend on brown background signs are located where trails and routes connect. The signs depicting an intersection with a specific number and reference to Clark County have been integrated on the map. The numbering system begins in southern Clark County and continues to the north.

**Intensive Use Areas**

Clark County has 3 ATV Intensive Use Areas for your enjoyment and play. A symbol has been incorporated on the map for easy reference and location. The areas allow operation of ATV's in a more open area with diverse terrain features. They were also created to minimize environmental impact within the county. Observe and follow all of the instructions listed as you enter the ATV Intensive Use Area. The instructions are for your safety as well as the other rider's safety. The designated Intensive Use Areas are only a small portion of the landscape you will get a view of while traveling on the trails and routes. All other areas not displayed on the map and not specifically signed as an ATV Intensive Use Area at the entrance is considered OFF TRAIL OPERATION OF AN ATV AND SUBJECT TO A CITATION.

**Brochure Explanation**

Clark County truly wants you to have an enjoyable ride and stay. Due to numerous areas that have been damaged within the county because of ATV's operating off designated trails/routes and for the best interests of the sport, additional information has been integrated in the brochure. This publication includes educational material concerning the out of door recreational activity you desire and the accountability that goes with it. **OPERATING ATV's APPROPRIATELY  
Respecting the Rights of Others**

Clark County strives to provide pleasant and memorable experiences for all visitors. Respecting the rights of others must be honored to assure the future of ATV recreation in Clark County.

Traveling within Clark County on an ATV, you will ride on TRAILS (a marked corridor on public or private property) and ROUTES (forest, township and county roads). TRAILS are marked with caution/warning signs, green channel posts, orange fiberglass posts, periodic ATV decals and orange blazers. ROUTES are marked with green and white ATV route signs, orange fiberglass posts and orange blazers. The Residents, Township Officials, and the Clark County Forestry and Parks Dept. request that you recognize the following:

- Be attentive and courteous when operating on multi use trails and routes. Trails and routes are shared with horses, mountain bikes, hikers, hunters and vehicles.
- Respect the rights and property of others.
- Do not damage living trees, shrubs or other natural features.
- Observe wildlife from a distance and do not harass or disturb wildlife.
- Stay on the designated trails and routes. The trails and routes are well marked throughout the trail system.
- Speed limits are posted within the trail system. Where not posted the speed limit on ROUTES are the same as any motor vehicle.
- When traveling within 150 feet of a residence you must slow your ATV to 10 M.P.H. or less.
- When within 100 feet of a person not on an ATV, snowmobile or motorcycle you must yield the right-of-way and the speed limit is 10 M.P.H. or less.
- Operate the ATV at a rate of speed that is reasonable or proper under the circumstances.
- POWER TURNS (Donuts) are destructive. Gravel roads and parking lots must be kept in pristine condition. Remember that somebody has to fix and maintain these areas.

All who reside within Clark County as well as the many recreational enthusiasts who visit us throughout the year appreciate your cooperation and respect. We welcome you to enjoy a pleasurable trail experience in Clark County.
